## How to make the most of your gift

A gift of a percentage of your estate will help make a difference to the lives of vulnerable people. It will hold its value better than a gift of a fixed sum. It is also an easy way to provide for the causes that are important to you after family and loved ones have been looked after.

Other ways you can include New Zealand Red Cross in your Will are:

## Some important wording
